IF YOU SHOW "VISIBLE" SIGNS OF SICKNESS YOU WILL BE DISQUALIFIED

CHEATERS WILL BE DISQUALIFIED

*Contestants limited to participating in only one eating contest.

*Contestants must be 18 years old or older.

***Contestants must sign a waiver prior to competing and show State Issued Picture ID for proof of age.**

*Contestants must check-in prior to noon the morning of July 4th, or the seat will be offered to attendees. No refunds will be issued for failure to check-in.

*Pizza - Limit 20 participants - winner based on person to **completely finish** a Large Domino's Pizza in the fastest time

*Yogurt - Limit 12 participants - winner based on person to **completely finish** Large Sprinkle & Pop Froyo in the fastest time

*Hot Dog - Limit 15 participants - winner based on person to eat the most Guinther's Hot Dogs in five minutes

-After the 5 minute time limit, contestant will have 20 seconds to swallow. Remaining contents after 20 seconds will not be counted. Partially eaten hot dogs will not be counted.
